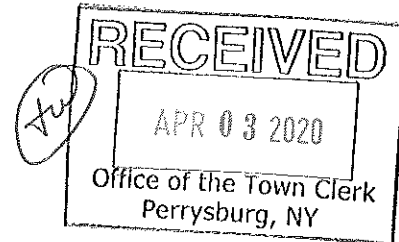

Town Clerk Report

The Town Clerk collected \$1,818.00 for the month of March. \$1070.36 was the town portion paid to the Supervisor. During the coronavirus pandemic, the office is open but residents are strongly encouraged to use the dropbox at the Town Hall, mail payments, or use the on-line payment portal for dog license renewal and/or water bills via the Town's website: www.townofperrysburgny.org

Tax Collector Report

For the month of March, the Tax Collector collected \$76,768.40 in Town and County Taxes and \$1527.68 interest & late fees. After refunding a taxpayer for correction on tax bill, the Supervisor was paid \$1302.47 for interest and late fees collected. All payments must now be made to the Cattaraugus County Treasurer's office.

Perrysburg-Processed 2,077,000 for daily average of 67,000 gallons. Began to read water meters. Were not able to install the new meters we hoped to due to the Covid. Our plan was to try and install the meters as close to read time as possible but felt like going into homes at this time was not the right thing to do.
