Planning / Zoning Board Report: New antennas going on cell tower in Versailles, discussed the proposed change to the commercial building permit fee schedule, surveys results were reviewed and most were positive.

Supervisor's Financial Report prepared by Bahgat & Laurito-Bahgat: On file in the Town Clerk's office

Town Clerk/Tax Collector Report: Town Clerk collected \$4,497 for the month of January. \$3,889.10 was the town portion paid to the Supervisor. The Cattaraugus County United Way just opened the Volunteer Income Tax Assistance program. Under this program they will be assisting taxpayers using H&R Block's My Free Taxes website. Anyone making under \$66,000 qualifies. Tax Collected has collected \$1.1 million in Town and County Taxes – the Town Supervisor has been paid in full \$631,220.42. The last day to pay taxes to my office is April 1st.

Highway Supt. Report: Plowing snow, dealing with ice, working on snow blower, shop work and equipment maintenance, dealing with thaw, opening pipes

Water/Sewer Dept. Report: Kirk Trumpore reported 1,464,693 gallons of water processed for January in Perrysburg and 181,549 for Versailles; purchased 4 new lock sets to be installed; had one off hour sewer call out.

- Supervisor Dabolt reported that a signed sewer contract with the Village of Gowanda has not been returned to the Town. She will follow up with Village of Gowanda
- Discussion about who residents should call in the event of an off hours emergency. Residents are to call the Gowanda Police Department who will get a hold of the Gowanda Water / Sewer Department.

Justice Report: Judge Dankert closed the following cases: 29 V/T, 1 Penal Law and 1 Animal Control. Reported \$3614 to the Comptroller (Town: \$1760, County: \$10, State: \$844)

- Court was awarded a JCAP Grant in the amount of \$12,887 to be used for air conditioning, file cabinets and tables.
- Town Prosecutor Rachel Mitchell submitted a letter of resignation effective January 31, 2019 due to a new job opportunity.
- Motion by Councilman Gabel, second by Councilman Becker to appoint John Grennell as Town Prosecutor effective February 11, 2019

BOARD MEMBER COMMENTS

 Board will send a letter to State Representatives expressing opposition to the Governor's proposal to eliminate state revenue sharing for towns and villages.
Perrysburg receives annual AIM (Aid to Municipalities) funding in the amount of \$14,755, an amount figured in the Town's 2019 Budget.

- Safety program for the cable crew working on Peck Hill Road is terrible no men working signs, cable spools left in the road, trucks not off the roadway. Serious safety concerns. Town will contact Spectrum.
